Meeting Called to Order

Approval of 2/7/22 Minutes

Lisa Napolitano

- A. Agenda and minutes were emailed to the Board in advance of today's meeting.
- B. Recommended changes to the past minutes: one name correction.
- C. Lisa made a motion to approve the minutes. Approved and seconded: Jean and Dawn.

Treasurer's Report

Maryanne Andrews

- A. Financial reports were emailed to the Board in advance of today's meeting.
- B. As of 2/28/22:

Checking: approximately \$95,000 Money Market: approximately \$80,000 Net Income: approximately -\$4,000

- C. There was a timing difference: some January expenses fell into February.
- D. We budgeted breakeven; we are at -\$4,000 net income for January and February 2022.
- E. Lisa made a motion to approve the financial reports. Approved and seconded: Jean and Leslie.

President's Report

Lisa Napolitano

- A. Casey Key Shoreline Resiliency Project (SRP)
 - 3/29/22 there will be a meeting with the county staff with Mike France, Mike Turillo, and Lisa.
 - 1. The staff will be presenting to the BCC.
 - 2. Normal beach project processes last 7 years. Lisa will explain the progress they have already made, such as the engineering study.
 - 3. Connie said that the county responds to interest. Connie suggested attending the meeting on 3/29. Lisa agreed that it's a good idea.
- B. Casey Key Road Repairs at North Key Revetment (500-700 Block of North Casey Key Road) and Mid Key Bluff (2104-2120 Casey Key Road): County road project
 - 1. 3/29/22 The staff is presenting to the BCC about the county road project.
 - 2. Mary Dee spoke with Curtis Smith about the Shoreline Protection Project county project.
 - a. The report will be included in the minutes.
 - b. North Key Site: the county staff has not taken the request to the BCC to change the Erikson contract to a seawall.
 - The design of the seawall is expected to be granted.
 - Mary Dee has a video of driving down CK Rd on a windy day with the water crashing over the car.
 - The county has not been holding meetings with residents. Curtiss said they will try to start up the meetings again.
 - c. They will do a presentation on 3/28.
 - d. The agenda item is open for public comment, but it is not a vote by residents. Anyone can sign up at the BCC meeting to request a few minutes to comment at the beginning or during the lunch break. If we speak at the upcoming BCC, we should remind the BCC how many years we have been working on this project.
 - e. Erickson has experience on CK.
 - f. Mid Key Site:
 - Permit for rock revetment denied about a year ago.
 - They are determining what will be permittable.
 - They have not worked out a resolution with the residents as far as the location of the seawall setback.
 - They cannot do anything until they move the water main, which is dangling off the west side of the road.
 - Public works is waiting for public utilities to move it from the west side of the road to the east side of the road.
 - They will have to close the road.
 - They will have to turn off the water.
 - 3. Mary Dee asked about the timing as it relates to the closing of the bridge. Hopefully they will coordinate.

Security

Dawn Doughty

- A. The Sheriff's Office is using a new platform called Roll Call.
 - 1. Previously, we didn't know if a shift was filled. Now we can see which shifts are filled or not. There is more reporting.
 - 2. Dawn is redoing the duty requirements.
 - 3. Overall, things are working ok.
 - 4. Main difference: we pay before the shift goes out to bid. Now we will pay in advance. If it's not filled, we will get a credit.
 - 5. They will clock in and clock out.
 - 6. We went from 16 to 22 shifts to have additional coverage for spring break.
- B. Leslie asked if we've had additional incidents lately. Dawn said we cannot tell yet, until we receive the incident report.
- C. The speed trailer is back on the key in the 3200 block. There's also one on Blackburn.
 - 1. Dawn has said it is making people slow down.
 - 2. Dawn said it will move south.
 - 3. Caroline requested capturing northbound vehicles' speeds. Dawn said it will when it moves to 1700 block.
 - 4. It might also move to south key.
- D. Chris asked about how many parking tickets. Dawn hasn't received the incident report. Clay might look at the Freedom of Information act for that.
- E. The security committee met. There are 9 members. They will meet again in April.
