Meeting Called to Order

Approval of 4/4/22 Minutes

Lisa Napolitano

- A. Agenda and minutes were emailed to the Board in advance of today's meeting. Lisa thanked Maryanne.
- B. Recommended changes to the past minutes: none.
- C. Lisa made a motion to approve the minutes. Approved and seconded: Leslie and Janet.

Treasurer's Report

Maryanne Andrews

- A. Financial reports were emailed to the Board in advance of today's meeting.
- B. Statement of Financial Position as of 4/30/22:
 - 1. Checking: approximately \$85,000
 - 2. Money Market: approximately \$80,000
 - 3. Total assets: approximately \$165,000
 - 4. Net Income (January-April): approximately -\$13,000. There was a timing difference: net income is negative until dues come in.

C. Annual Picnic

1. The board members thanked Leslie for her time and effort to make the picnic such a success!

- 2. The board members expressed their gratitude to Terry Dickson for generously allowing us to hold the picnic on her lot, as well as offering her lot for the picnic next year.
- 3. Headcount: 132 adults and 11 children.
- 4. Picnic income: \$5,910. Picnic expenses: \$6,619. Picnic shortfall: \$709.
- D. Caroline made a motion to approve the financial reports. Approved and seconded: Dawn and Jean.

President's Report

Lisa Napolitano

A. Welcome Back Party planned for Saturday, November 5, 4-7pm

Dawn heard suggestions for a fall Welcome Back Party. Lisa suggested planning the date now.

B. Blackburn Point Bridge

- 1. Temporarily closing on the hour and half hour.
- 2. The county said it is up to the Coast Guard to make the determination of whether this timing can be permanent, especially with the Albee Bridge Construction coming.
- 3. Clay said an individual, association, county, or state can initiate a Coast Guard evaluation of a rule for the bridge.
- 4. Connie and Julie said these traffic studies have been done.
- 5. Connie said we need a new one at the right time of the year.
- 6. Clay said he will go to the traffic planning department to get the traffic counts for the other bridges in the county for comparison.
- 7. Clay said there is a time limit of 180 days for the change in schedule, before we need to make another case to the county.
- 8. Clay and Connie will work together on this bridge initiative.

C. Houseboats

- 1. An additional houseboat is being added.
- 2. Bill Merill is going to meet with County Environmental Enforcement.
- 3. Code Enforcement is going to get involved, because mangroves are being removed.
- 4. According to the zoning code, this is within the conservation district.
- 5. The Fish House was grandfathered in as non-conforming use.
- 6. There was a technicality when the issue was posted, so the houseboat owner won the appeal.
- 7. Mary Dee and Leslie will work together on this.

D. Casey Key Shoreline Resiliency Project (SRP)

- 1. H&M Engineering is working with permitting. The county is collaborating with SRP.
- 2. We should have more information at the end of the month.
- 3. Lisa will set up a zoom in June with the working group with an update.
- 4. Sean asked about a rough estimate on shoreline repair.
 - a. Lisa thinks it will take a couple of years.
 - b. The SRP is doing as much as they can.
 - c. Questions should be directed to Mike Turillo and Mike France.

E. Herald-Tribune

- 1. A Herald-Tribune reporter contacted Lisa about rising tides and shoreline resiliency.
- 2. Lisa put the reporter in touch with H&M Engineering.

- 3. Lisa invited the reporter to come and see the erosion and road damage. The reporter brought a photographer.
- 4. The reporter asked Lisa for some representatives, so Lisa gave her some names. Connie is being interviewed Thursday morning.

Security

Dawn Doughty

A. Intelligence2Action reports

Calls for service were up due to spring break:

- a. February: 29
- b. March: 76
 - i. Most incidents were in the parks.
 - ii. One felony.
 - iii. Illegal parking: 10 counts.
 - iv. Some disorderly and intoxications. Some suspicious persons and incidents.
 - v. Some vehicles stopped for speeding: some residents and some not.

 Residents complained about a young male driver speeding and driving recklessly.

 The Sheriffs are aware of who it is.
- B. Clay got an official determination from the Parks Department:
 - 1. If vehicles are parked in front of your house, you should call the Sheriff's Office.
 - 2. If vehicles are parked in the parks, then it is up to the Parks Department.

C. Security cameras

- 1. Dawn has been researching license plate reader cameras for CK for months.
- 2. The board members attended Zoom demos with Flock Safety.
- 3. Dawn has discussed it with the Safety & Security Committee.
- 4. Dawn has spoken with the county about Flock.
 - a. Flock has a contract for 75 cameras throughout the county.
 - b. Flock is connected directly to the Sherriff's office. The SO will see the alerts before we do. We will see on our dashboard that the SO has been given an alert. Clay asked if the SO charges for that. Dawn said no.
- 5. Flock offers live video with search criteria.
 - a. It will pick up motorcycles, bicycles, pedestrians. It does not capture faces.
 - b. It will provide traffic counts.
 - c. It is solar, cloud based.
- 6. Flock total cost \$9,600/year. \$1,000 to install 4 cameras. We will have Flock come here to determine where they recommend placement.
- 7. Dawn proposed a vote to move forward. Leslie seconded.
 - a. Mary Dee asked if we can afford this.
 - b. Lisa says we've already raised the dues for it.
 - c. Maryanne said we need to keep the membership up.
 - d. Janet said membership is up.
 - e. Dawn said we have raised the money for next year, but not for this year. Installation is 6-8 weeks. So, installation would take place in the fall.
 - f. The board voted unanimously in favor of Flock Safety security cameras. We have a quorum.

 - 5. Dawn said there is simplicity in providing a stand-alone booklet.
 - 6. Lisa said one advantage of online is that it is always current.
